

# BARNESTORM, INC. Intellectual Property License

## 1. BARNESTORM, INC. Licensor

Barnestorm, Inc. Grants this license. “BARNESTORM, INC” and “BARNESTORM” are individually referred to herein as an “BARNESTORM, INC. Licensor”.

## 2. No Agency

This License forms a separate agreement between you and the BARNESTORM, INC. Licensor without any further action required by the parties. BARNESTORM, INC. Licensor grants this License in its own capacity and no other party is acting as agent of BARNESTORM, INC. Licensor or has capacity to bind BARNESTORM, INC. Licensor.

## 3. License
